

EXPLANATION OF YOUR TAX BILL

1. Local government collects for each of these taxing jurisdictions.
2. Local government assessed value of land.
3. Local government assessed value of buildings.
4. Local government assess value of land and buildings.
5. Municipalities total assessed value divided by State Equalized value (as a %).
6. A value estimate made by dividing this parcel's total assessed value by the average assessment ratio.
7. Indicator that delinquent taxes are due on this property.
8. Amount from State to reduce each tax bill.
9. Gross tax due for current year to each tax jurisdiction. For comparison, the previous years taxes are listed with percentage change.
10. Lottery & First Dollar Credit amounts from State.
11. Total Assessed value multiplied by the net assessment value rate.
12. The net assessed value rate or mill rate before credits.
13. Net property tax due payable in one or two installments.
14. Special assessments or delinquent charges due from the municipality.
