The following list of fees may require prepayment and shall be charged for the designated services performed by the Jackson County Sheriff's Office:

Additional service attempts	Per attempt	\$25.00
TRO/Injunctions	Domestic abuse, child abuse, individual at risk; 813.12, .122, .123; 814.61(1)(d)	\$0
Harassment TRO/Injunctions	Harassment if the petitioner alleges stalking, sexual assault, physical violence, impaired physical condition, or threats: 813.125, 814.61(1)(e)	\$0
Harassment TRO/Injunctions	Without domestic abuse, child abuse or individual at risk allegations 814.61	\$75.00
TRO/Injunctions	Combined actions, 813.127; 814.61(1)(e)	\$0
TRO/Injunctions	File foreign or out-of-county protective order	\$0
TRO/Injunctions	Other injunctions and restraining orders	\$75.00
Stand by time	Deputy hourly rate of pay	Depends on Deputy assigned
