15. NEW BUSINESS:

- **CONDITIONAL USE PERMIT PETITION # 2017-01** as requested by William Waughtal, owner and Lunda Construction, applicant on property located in the NE1/4-SW1/4, Section 22, T21N, R4W, Town of Brockway, Jackson County, WI. The request is to allow for a crusher to be brought onto the site to crush existing materials. This is proposed to be a temporary operation; not permanent.

- **ZONE CHANGE PETITION # 2017-02** as requested by Har-Hur Farms, owner and Garrett Goodenough, applicant on property located in the NE1/4-NE1/4, Section 28 and the SE1/4-SE1/4, Section 21, all in T19N, R6W, Town of North Bend, Jackson County, WI. The request is to change 12.04 acres of the Official Zoning Map as follows:
 1. 5.4 acres from the A-1 (Agriculture) District to the R-6 (Rural Residential) District for the construction of a single family home being Lot 7 of CSM 3959.
 2. 6.52 acres from the A-1 (Agriculture) District to the B-2 (Outlying Business) District for the existing shop building, which has been onsite since prior to the town participating in comprehensive zoning being Lot 8 of CSM 3959.

- **ZONE CHANGE PETITION # 2017-03** as requested by William and Bernice Herzberg on property known as Lot 3 of CSM 3956 located in the SW1/4-SW1/4, Section 28, T21N, R5W, Town of Albion, Jackson County, WI. The request is to change 5.13 acres of the Official Zoning Map from the A-1 (Agriculture) District to the R-2 (Residential) District for the construction of a single family home.

- **ZONE CHANGE PETITION # 2017-04** as requested by Kevin and Amanda Beilke on property located in the NE1/4-SW1/4, Section 22, T21N, R5W, Town of Albion, Jackson County, WI. The request is to change 3.68 acres of the Official Zoning Map from the R-2 (Residential) District to the R-6 (Rural Residential) District to allow for horses to be kept at the site.
